ANNUAL ACTION PLAN AMENDMENTS  
PUBLIC NOTICE

**December 10, 2021**

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III and Community Development Block Grant – Disaster Recovery (CDBG-DR), Community Development Block Grant – Coronavirus (CDBG-CV) and Emergency Solutions Grants – Coronavirus (ESG-CV) funds. This strategy document is called the Consolidated Plan, and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

**2018-2021 CDBG Funding:**

Project C2018-030 Harris County Water Control and Improvement District #36 -Wastewater and Lift Station Improvement Phase III (Precinct 2). Obligate \$14,171.82 in 2020 CDBG Funds. Total project funding, including previously awarded amounts, will be \$558,722.82.

Project C2019-028 SER for Jobs for Progress of the Texas Gulf Coast, Inc.- Workforce Training Center (Precinct 2). Obligate \$78,929.42 in 2020 CDBG Funds. Total project funding, including previously awarded amounts, will be \$2,115,247.52.

Project C2020-022 Crosby MUD- Replacement of Waterlines Projec( Precinct 2). Obligate \$87,338 in 2020 CDBG Funds. Total project funding, including previously awarded amounts, will be \$504,457.00

Project C2020-028 Harris County Municipal Utility District 148 - Wastewater Treatment Plant Expansion Project. Deobligate \$1,000,000.00 in 2020 CDBG Funds. Total project funding, including previously awarded amounts, will be \$0.00.

Project C2020-045 Harris County Municipal Utility District 148 – Lift station #2 Improvements\_Phase 2 (Precinct 1). Deobligate \$415,570.00 in 2020 CDBG Funds. Total project funding, including previously awarded amounts, will be \$138,647.00 (remaining leverage balance).

Project C2021-037 Harris County Precinct 3-Mossy Oaks Subdivision Roadway Asphalt Rehabilitation Project (Emerald Forest). Obligate \$447,226.50 in 2020 CDBG Funds. Total project funding, including previously awarded amounts, will be \$1,447,226.50.
