ANNUAL ACTION PLAN AMENDMENTS
PUBLIC NOTICE

May 12, 2023

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program Funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III and Community Development Block Grant – Disaster Recovery (CDBG-DR), Community Development Block Grant – Coronavirus (CDBG-CV) and Emergency Solutions Grants – Coronavirus (ESG-CV) Funds. This strategy document is called the Consolidated Plan, and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2019 CDBG Funding:

Project 2019-021 Harris County Community Services Department- Health and Safety Home Repair Program (Countywide). Deobligate \$41,393.49 in 2019 CDBG Funding. Project completed. Total project funding, including previously awarded amounts, will be \$58,606.51.

2020 CDBG CARES Act Funding:

Project 2020-044 Harris County Community Services Department- Affordable Housing Study (Countywide). Deobligate \$0.00 in 2020 CDBG CARES Act Funds. Total project funding, including previously awarded amounts, will be \$398,344.40.

2022 CDBG Funding:

Project 2022-004 Harris County Community Services Department- Harris County Home Repair Program (Countywide). Deobligate \$300,000.00 in 2022 CDBG Funds. Total project funding, including previously awarded amounts, will be \$500,000.00.

Project 2022-006 Harris County Community Services Department- PFI Program. Deobligate \$1,586,035.84 in 2022 CDBG Funds. Total project funding, including previously awarded amounts, will be \$7,872,775.26.

Project 2022-011 Harris County Community Services Department- Harris County Single Family Program (Countywide). ***Corrected amount from previously published notice: Obligate \$1,886,035.84 in 2022 CDBG Funds.*** Total project funding, including previously awarded HOME Funds \$2,736,223.27 (2017 prior year funds of \$42,284.30, 2019 prior year funds of \$693,938.97 and current year funding of \$2,000,000.00), total project will be \$4,622,259.11.
